Machinery and Equipment, Business Vehicles, Leasehold Improvements, Working Capital, Real Estate

Interest Rate

Priced above Prime Rate, based on Size of Loan, Term of Loan, and Collateral

Maturity

Real Estate: 5 year balloon; Machinery/equipment: 2-5 years; Working Capital: 1-5 years

Collateral

Through security agreements, CFF may take positions in real estate, fixed assets, vehicles, inventories and receivables.

Fees

Application costs: \$50 for all loan applications under \$50,000; \$100 for all applications \$50,000 or more
Closing costs: One percent of the total loan amount and a document preparation fee.
